Last month Mrs. Marion Taylor kindly offered to make knitted slippers and donate them as a fund raiser for GARDS.

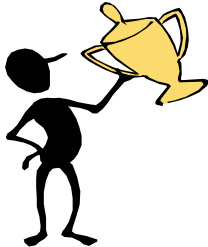
She makes these slippers out of recycled wool from old jumpers and cardigans.

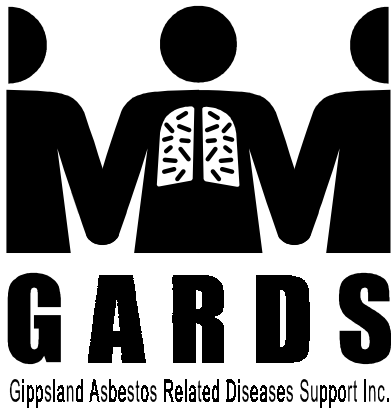
